<b>Prohibited Articles</b>		Prohibited Articles  The importation of the following items into a container which contain household goods and personal effects are forbidden:  <ul style="list-style-type: none"> <li>• Food of any kind (including canned food, spices or pet's food).</li> <li>• Liquor or wine, Whisky.</li> <li>• Perfumes (fragrances).</li> <li>• Sprays (of any kind).</li> <li>• Shampoos, conditioner, etc.</li> <li>• Body Creams (of any kind).</li> <li>• Bath Articles (shampoo, creams, soap, shaving cream, etc.).</li> <li>• Cleaning Solutions (bleach, detergents, soap, liquids to clean glasses or any other surface, etc.).</li> <li>• Drugs.</li> <li>• Medicine (you can NOT include medicine of any kind).</li> <li>• Cigars, cigarettes, etc.</li> <li>• Firearms and ammunitions.</li> <li>• Pornography material of any kind.</li> </ul>
